Legal form and business activity

Our client relationships are based on a service commitment by mawyc insurance, a public limited liability company (Public Limited Company -PLC-) under Belgian law.

The company's purpose consists of providing independent insurance intermediation services — i.e., activities involving advising on, proposing, or carrying out preparatory work for the conclusion of insurance contracts, or concluding such contracts, as well as assisting in the management and execution of insurance contracts, particularly in the event of a claim — as well as related ancillary services in the field of risk management.

Financial supervisory authority

The register of insurance intermediaries is maintained by the FSMA (Financial Services and Markets Authority), located at Congresstraat 12-14, 1000 Brussels (Belgium) and can be consulted at www.fsma.be.

Wyckaert-Comarit NV complies with the applicable registration and sectoral requirements in accordance with authorisation number 013104.

General terms and conditions, applicable law and jurisdiction

Our general terms and conditions apply to all our insurance intermediation services. These general terms and conditions are available in Dutch, French, and English, and can also be provided to our clients free of charge upon first request. In the event of any differences in interpretation and/or discrepancies between the respective translations of the applicable provisions and the original Dutch version, the Dutch text shall at all times prevail. The Dutch version shall be solely and exclusively decisive for the correct interpretation and application of these provisions.

Only Belgian law applies to all aspects of our services, and the Belgian courts and tribunals have exclusive jurisdiction to settle any disputes related to our services.

Communication

You can communicate with our office by e-mail, letter (post), telephone, or you can always schedule a physical meeting. By providing your e-mail address as a means of communication, you agree/accept that mawyc insurance may send you all letters, information, and documents electronically or make them available via its website.
