We believe it is important to inform you why we request your personal data and how we handle it. This policy clarifies how your personal data is processed and which cookies, if any, are used, for what purposes, and in particular in accordance with the current general data protection regulations (GDPR).

On this website, you can consult our cookie policy in English, Dutch, and French. In the event of any differences in interpretation or discrepancies between the respective translations of this policy and the original Dutch version, the Dutch text shall always prevail. The Dutch version is solely and exclusively decisive for the correct interpretation and application of this policy. Please read this cookie policy and our privacy policy carefully, as they contain essential information.

<u>www.mawyc.be</u> uses cookies and similar technologies in accordance with the General Data Protection Regulation (GDPR) and taking into account the current provisions of the Belgian Telecommunications Act, pending the entry into force of the European ePrivacy Regulation (ePR).

1. Cookies

A cookie is a small text file that can be stored on the hard drive of your computer, mobile phone, smartwatch or tablet by a web browser, when you visit a website. The information stored therein can be sent back to the server each time the browser requests a page from the server. In this way, the website recognizes your browser and can, for example, retain your choice of language.

There exist two main kinds of cookies: session cookies and persistent cookies. Session cookies are deleted from your computer when you close your browser, whereas persistent cookies remain stored on your computer until deleted, or until they reach their expiration date.

2. Permission for the use of cookies

Your consent is required for the use of certain cookies. By visiting this website, you can agree to the placing of relevant cookies. We do this by means of a so-called 'cookie banner'.

Cookies help mawyc insurance to optimize your visit to the website. However, you can restrict or delete cookies at any time by changing your browser settings (See "Cookie management").

3. Which cookies does this website use and for what purpose?

3.1. There are different types of cookies. We distinguish the following cookies according to their purposes: there are essential or strictly necessary cookies and non-essential cookies (analytical, functional and targeting cookies).

mawyc insurance, administrator of this website, uses the following types of cookies on www.mawyc.be:

STRICTLY NECESSARY COOKIES:

These cookies are strictly necessary for purely technical reasons to ensure the proper functioning of the website and cannot be disabled in our systems. They are usually only set in response to actions you take yourself, such as setting your privacy preferences.

NON-ESSENTIAL COOKIES:

These cookies are not in themselves necessary for the functioning of the website, but they do help to offer an improved and personalized website.

Analytical cookies

mawyc insurance uses Google Analytics cookies. It generates statistical and other information about website usage through cookies, which are stored on users' devices. For more information, please visit the privacy policy page at https://policies.google.com/privacy/frameworks?hl=en-US.

Session cookies

By using a session cookie mawyc insurance can see which parts of the website you have visit. This way mawyc insurance can adjust the service as much as possible to the surfing behaviour of her visitors. These cookies are automatically deleted when you close your web browser.

4. Your rights

Strictly necessary cookies are placed based on our legitimate interest (Art. 6.1.f GDPR). For all other cookies, we request your active and informed consent via our cookie banner, in accordance with Article 129 of the Belgian Act of 13 June 2005 on electronic communications and in line with future requirements of the ePrivacy Regulation. (see FB T&T!)

Since cookies can constitute a processing of personal data, you as a data subject are entitled to the lawful and safe processing of the personal data. You can find more information about how we collect and process your personal data, as well as your rights, in our privacy policy.

You can exercise these rights by sending an email at privacy@mawyc.be. To prevent abuse, we can ask you to identify yourself adequately.
